Aileen Patton gave an update on the Lindsay Municipal Hospital Authority. Performed 22 surgeries, 25 Procedures, 192 ER visits, 86 In Patients, 95% Staffing Rate.

Staff report was given by John Noblitt with updates on the swimming pool project, AMI/AMR meter project, Water Issues.

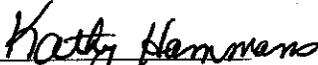

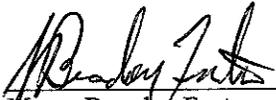
No New Business.
