Motion was made by Wilbourn and seconded by Spivey to adopt Ordinance # 519 amending the Lindsay Code of Ordinances, Chapter 5, Building Regulations, Article IV, Dangerous Buildings, adding Section 5-90, Condemnation and approving the emergency clause in Ordinance # 519. Attorney Dan Williams administered the Oath of Office to new council members Hassler, Rutledge and Turner


Item # 11 – Presentation of OMAG Recognition Program was moved to bottom of agenda so council members could attend the training at the conclusion of the regular business.
